

**AGREEMENT FOR USE OF
HUFF’S CHURCH PROPERTY**

This Agreement (hereinafter “Agreement”) entered into this ____ of _____, 20____, by and between Huff’s Union Church, Inc., a Pennsylvania charitable corporation, 540 Conrad Road, Alburtis, PA 18011 (hereafter “Huff’s Church”) and

(hereafter “User”) for the _____ day use of either:

A. The Picnic Grove, consisting of food preparation and serving pavilion, picnic tables pavilion, stage and seating, rest rooms, children’s play area including swings, “tot lot” and adjacent grassy area; or

B. The Chapel, Lower Level consisting of the kitchen and dining area, but not including upstairs auditorium.

C. The Chapel, Upper Level Auditorium. If in addition, use of lower level kitchen and/or dining room is desired, user must reserve B (lower level) and an additional Use donation is requested for use of both levels.

User selects (A, B, C) _____, for date(s) _____ from _____ m. to _____ m. for the following event _____.

Arrival and set-up shall not begin before stated start time which shall not be before 8AM. Events should end at least by 9PM and User agrees clean-up shall be completed and all persons vacate the property by the stated ending time which shall be no later than 10PM. The User agrees to follow the Rules for Use of the facilities that is provided with this Agreement.

Dates are not subject to refund for cancellation unless Huff’s Church is notified within 48 hours of the scheduled event.

Huff’s Church agrees to provide the premises subject to this Agreement in broom clean condition, and User agrees to remove all trash and leave the premises in broom clean condition at its/his departure. User shall be present upon the premises during its/his agreed upon use of the premises and shall be responsible for care and supervision of any minors, and for the behavior of all persons upon the premises in consequence of the entering into of this Agreement except for persons associated with Huff’s Church.

Representative(s) of the Church may be on the property during the event and it is expected that the User and guests will comply with representatives’ requests or directions regarding the use of the Church facilities.

This Agreement is not assignable by User without the express written approval by Huff's Church.

User agrees that no persons upon the premises in consequence of entering into this Agreement on account of User shall bring with them or use either alcohol or any illegal drugs, and User shall indemnify and hold Huff's Church harmless for any and all liability or damages, including counsel fees that might otherwise accrue to Huff's Church for violation of this provision.

User agrees to indemnify and hold Huff's Church harmless for any and all claims of persons upon the premises in consequence of entering into this Agreement except for persons associated with Huff's Church and except for gross negligence in the condition of the subject premises caused by Huff's Church or its agents at the time of use.

Huff's Church may request evidence of insurance from any person or organization that wishes to use the facilities.

Daily donation for use of the Picnic Grove is \$_____. Daily donation for use of the Chapel is \$_____. Donation amounts are subject to change without notice by Huff's Church. Huff's Church reserves the right to revise the requested Use Donation and rules for use of any Church property depending on the specific nature of any event.

This Agreement shall be binding upon the heirs, executors, administrators and assigns of the parties to this Agreement.
